

Traffic Channeling Corridors





The USMC has been working on this proposal with the FAA since 2009








Enclosure 1 - Withdrawal Map

Nevada Aviation Advisory Committee, Advises NDOT AVIATION each year & Selects the Program List of Airport Projects

> NDOT AVIATION administers the <u>Fund for Aviation</u> State Matching Grant Program, and reimburses Airport Owners for their completed Airport Projects

Fund for Aviation –Matching Program

Ely / White Pine County is Awarded an FAA Grant for \$2,450,000 to Repair Runway 18/36

Ely needs 93.75% of \$2,450,000 OR <u>\$153,125</u> for their FAA Local Match (6.25%)



Fund for Aviation had sufficient funds to match FAA Local Grants at the rate of 28% in this Example Grant Year based on ALL Grants given in NV

Ely / White Pine County Completes the project and Repairs Runway 18/86 with FAA and Local Funds



NDOT Aviation Reimburses Ely Airport / White Pine County for 28% of their Local Match or \$153,125 x 28% = \$42,875
